3. Multiple bids (technical and/or financial bids) from same IP address will result in disqualification of all bids submitted from that IP address.

#### 7. **Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.
